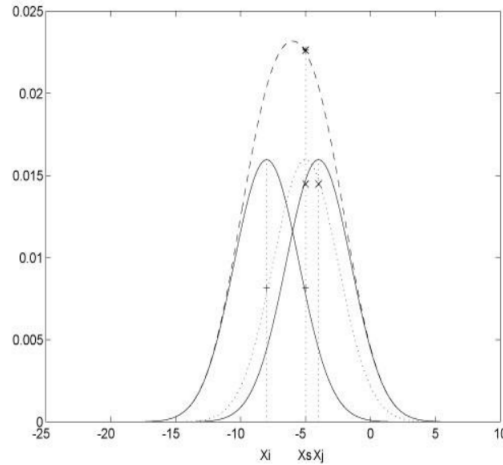


Figure 1: Figure captions should always be positioned below the figures The last sentence of a figure caption should generally end without a period
